1. Speed Sign

This department has received funding to cover the purchase of the portable speed sign. This department will only need to spend \$400 for shipping and additional mounting brackets so that we can easily move the speed sign to other locations around the city.

2. East Manchester Street

Regarding the speed sign. East Manchester Street will be the primary place for this sign during the busy summer and fall months. This department is following up to find out if this committee wants anything else done regarding East Manchester Street.

3. Stop Sticks

This department used the money donated from Ted's Piggly Wiggly to purchase two sets of Stinger Stop Sticks. The total purchase was \$1070 dollars which was completely covered by the donation. Once again this department greatly thanks Ted's Piggly Wiggly and all that came out to support that fundraising effort.

4. Sergeant Position

The sergeant position has been vacant since October 2015 and this department feels it's time to fill this position. The sergeant position provides continuity of supervision when the chief of police is out of the area or unavailable. In law enforcement chain of command and having a system in place for command and supervision is vital.

I have attached an updated job description of the sergeant position. This description and a posting for this position will be posted internally until February 21st where at that time candidates will be interviewed by the Chief and the final selection will be brought before this committee and council in March for final approval.



Accountability Objective: Supervise and manage the Markesan Police Department in

Nature and Scope:

This position reports to the Markesan Police Chief. This position is responsible to oversee the members of the Markesan Police Department in the event the Chief of Police is unavailable. Performs supervision over other officers and assigs shifts or other job-related responsibility as directed to perform. Insures for the safety and protections of life and property and the maintenance of order, traffic flow and compliance of laws and ordinances through direct action and or subordinate employee actions. Although work is preformed in accordance with general departmental directives and policy, the employee as a supervisor must exercise great amounts initiative and judgement.

Other responsibilities:

- 1. Takes command of the Markesan Police Department when the Chief of Police is unavailable or unable to perform his or hers duties.
- Will be required to remain within the vicinity and be available for members of the Markesan Police Department when the Chief of Police is unavailable or unable to perform his or her duties.
- 3. Check all department equipment and vehicles each and every month to ensure the equipment is properly maintained and to report to the Chief of Police any findings that would otherwise be a detriment for officer safety and the safety of the citizens of the community we serve.
- 4. Department's lead Detective: Performs investigative duties as assigned by the Chief of Police handling a variety of criminal offense complaints. Must prepare detailed investigative reports for a criminal court prosecution and follow any instructions from the district attorney's office or the Chief of Police regarding follow-up information pertaining to criminal cases.

In addition, in order to maximize City operations subsidized by tax levy, the annual Contingency Fund balance shall be designated as non-tapsing with the following exception provision: If on December 31 of any given fiscal year, the General Fund reserve balance shall fall below the General Fund Policy amount as established herein, the December 31 Contingency Fund balance shall tapse to the General Fund, in entirety or in an amount as determined by the Common Council, sufficient to bring the General Fund reserve balance into compliance with this policy. |
