Betsy: Thank you for providing the pole numbers. Based on our Category B light (150-watt hps is the old type; 72-watt LED is our new type), your costs would be as follows for each light:

If mounted on 6' bracket:

- \$83.76/year PLUS 686 annual kilowatt hours x \$.066 (\$45.28) = \$129.04/year / 12 months = \$10.75/month

If mounted on 12' mast arm:

- \$109.56/year PLUS 686 annual kilowatt hours x \$.066 (\$45.28) = \$154.84/year / 12 months = \$12.90/month

If mounted on an existing pole, there is no installation charge.

To have these installed, we will need a "formal" letter or email of request sent to me.

Please note that the distance from these poles to our nearest existing light is less than 200'. I suggest that the City establish an ordinance stating the desired distance between lights so that there is some consistency. In other neighborhoods, the distance is significantly higher between lights. Some municipalities have an ordinance that allows for lighting an intersection, but not mid-block in residential areas. This, of course, is the discretion of the municipality.
