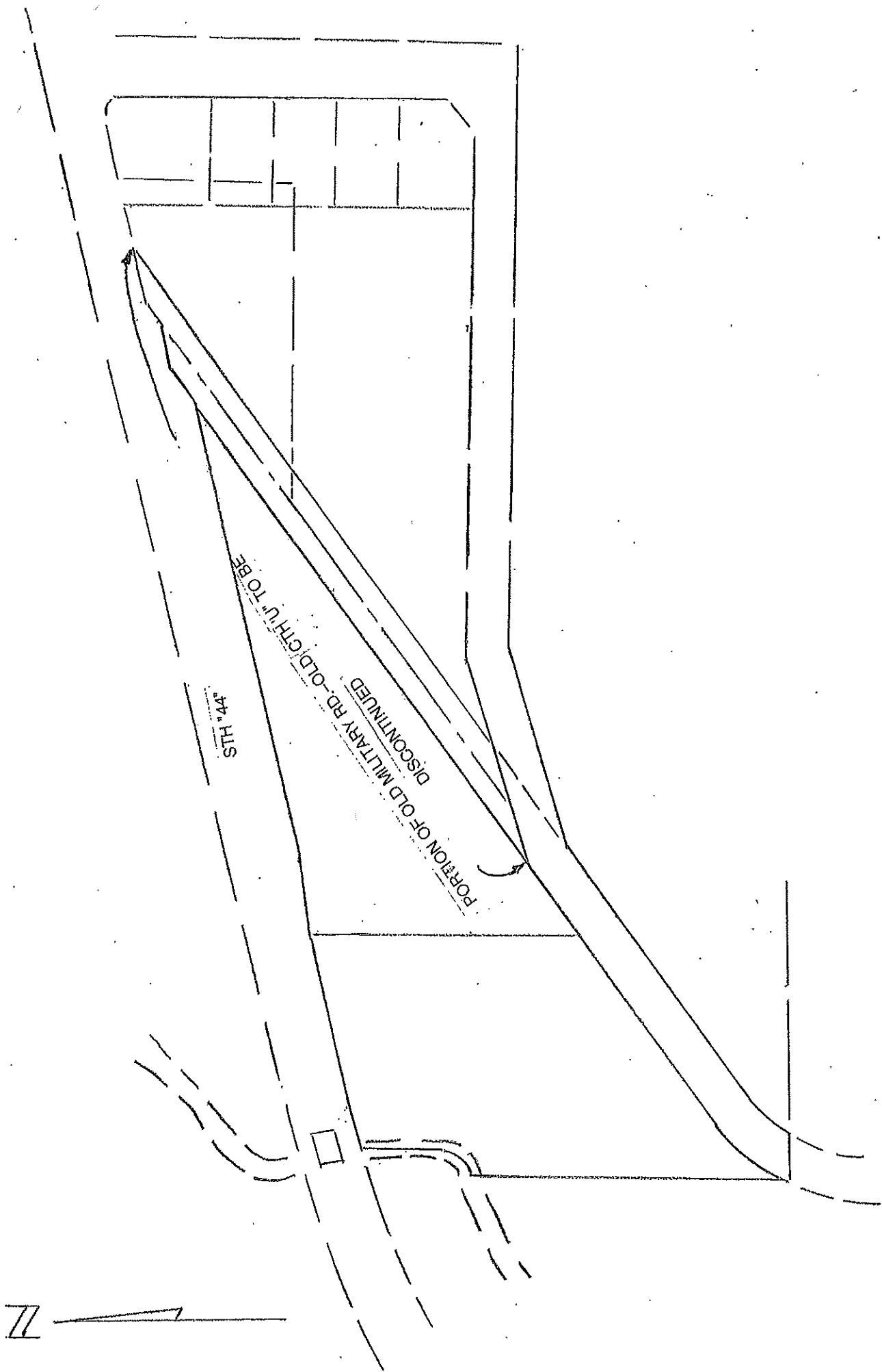

Hi Rich - See attached sketches "A" & "B". I think you need at least a Plat of Survey showing the portion of road to be discontinued - "A". After the City takes action to discontinue, they need to quit claim the portions to the three adjoining property owners - any future title search will reveal that any Interest the City had, reverted back to the three adjoiners - no questions. Then a CSM of the two Lots and the road dedication completes the land division & gives the City title to Airport Drive as it extends to present CTH"U".

Note; the other sketch, showing various outlots as part of the old R/W, shows how you and the neighbors could split the old R/W , before the CSM is finalized. Since the new lots would have access to the highway & to the local road, driveway permits onto "44", if wanted, need to be addressed. Discuss? In tomorrow for a short time, then off 'til next week.
