#### 1. Preliminaries

- **1.1** Meeting was called to order by Mayor Rich Slate at 7:00 pm.
- **1.2** Present were Ald. Abendroth (via telephone), Ald. Prill, Mayor Slate, Ald. Thiem, Ald. Triemstra, Ald. Kazda and Clerk-Treasurer Betsy Amend. Also present were Kristin Radtke from the Berlin Journal, Chief Will Pflum and Officer Brennan Crowley. Ald. Tetzlaff was absent.
- 1.3 Pledge of Allegiance
- **1.4** No Citizen's comments.

# 2. Approval & Review of Minutes, Reports & Correspondence

- **2.1** After review, motion Triemstra/Thiem to approve the July 13, 2021 Common Council minutes as presented; motion carried 5-0.
- **2.2** After review, <u>motion Abendroth/Triemstra</u> to approve April 13, 2021 Common Council Closed Session minutes as presented; <u>motion carried 5-0.</u>
- 2.3-2.7 After review of all items, motion Prill/Triemstra to approve the July Police Report & August Schedule, Public Property & Health minutes of August 3, 2021, Finance, Personnel & Safety minutes and Closed Session Finance minutes of August 3, 2021, Streets, Buildings & Utilities minutes from July 8, 2021 and August 3, 2021and the July 2021 Library's Director's Reports and Markesan Library Board minutes of July 15, 2021; motion carried 5-0.

### 3. Approval of Claims:

- 3.1 The Finance, Personnel & Safety Committee reviewed City and Utility checks and recommended approval to the Council. Motion Prill/ Kazda to approve the following vouchers as presented: City Checks #36760-36792, electronic payments #EFT 1131-1134, and direct deposits #4431-4475 in the amount of \$96,998.32, and Utility Checks #12807-12824 in the amount of \$35,006.49; motion carried 5-0 on a roll call vote.
- **3.2** After review, by consensus the July 2021 Treasurer's Report was filed for audit.

## 4. New Business

- **4.1** Following discussion, <u>motion Thiem/Triemstra</u> to accept Officer Neumann's resignation; motion carried 5-0.
- **4.2** Motion Thiem/Triemstra to approve hiring Brennan Crowley as the new full-time patrol officer at the current wage scale of \$16.91 with a hire date of August 11, 2021; motion carried 5-0 on a roll call vote.
- **4.3** Following discussion, <u>motion Abendroth/Prill</u> to immediately start the property maintenance procedure with Northern Development, the owner of the trailer park, by General Engineering Co. sending out a letter to them giving them 30 days to rectify the maintenance issue; motion carried 5-0.
- **4.4** Motion Triemstra/Kazda to approve the 2021 Budget adjustment: Move \$2,300 from #5312000 Public Works Machine & Equipment, \$500 from #533110 Curbs & Gutters, \$500 from #5331200 Traffic Signs & Markings, and \$400 from #5345000 Parking Lots to #5331000 Road Maintenance to increase it by \$3,700; motion carried 5-0 on a roll call vote.
- **4.5** Motion Kazda/Thiem to approve the Tuition Reimbursement Policy; motion carried 5-0 on a roll call vote.
- **4.6** Motion Prill/Triemstra to approve the bid from August Winter & Sons, Inc. for \$67,838 to replace the City Hall boiler; motion carried 5-0 on a roll call vote.
- **4.7** Information only that there is a vacant position on the Planning Commission Committee. Mayor Slate asked the Council to advise him of someone to fill the position if they knew of someone. No Action.
- 4.8 Motion Thiem/Triemstra to approve the written notice of claim for Victoria Tripp; motion carried 5-0.
- **4.9** Motion Kazda/Triemstra to grant an Operator's License for the period ending June 30, 2022 to Erin L Krueger; motion carried 5-0.
