## New 2023 Dodge Durango

Obtaining new squad car's over the past couple of years has become a real challenge for law enforcement across the country. Auto manufacturers are making less and less squads as they are selling regular autos at unbelievable amounts and at sticker price or above.

This department knew that we would need to replace the 2014 Ford SUV in late 2023 and because of that learned that the ordering window for municipalities was very short. This department was lucky enough to just make it in the ordering window last September for a Dodge Durango. The timeline was that most likely it would be done and ready in summer or could be as late as fall of 2023. I was advised when it was ready if we were unable to take ownership of the Dodge Durango, there would be no penalty and they would keep as a stock vehicle.

Well Dodge ended up being ahead of schedule as parts and items came in and they were able to make the Durango's quicker than they thought. This department received a call from Ewald Automotive Group at 2:00pm on 03/15/2023 that our Dodge Durango was in and that they would like to drop off ASAP.

I advised Ewald that the completion was done unexpectedly early and thus I would need time to see if the Common Council would like to make the purchase at this time.

This department believes buying this squad car makes good sense as it will allow us to take the 2014 SUV out of service and sell it at auction. Ford SUV's are still selling for good prices, most this age and mileage are going for 8k-10k.

It would also ensure that we have a new squad car whereas if we pass and wait until the next ordering window, it could be late 2024 before we are able to obtain a new squad.

This department can purchase this new squad and have it outfitted by not going over budget. That is possible because this department has \$7,000 in grant money from the Local Law Enforcement Agency Initiative, the sale of the Ford SUV and money built into the 2023 budget for new equipment for a new squad.

Ewald said that we can take receipt of the vehicle without payment and that we can work on financing after we take ownership. The cost of the 2023 Dodge Durango squad car will be \$39,208.

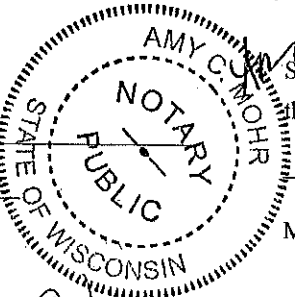
