October Public Property and Streets

Public Property:

Brush at the recycling center is chipped and leveled out for more brush

Removed all the sand from the Kiwanis Volleyball courts and hauled it to the recycling center. Free sand was posted on the City website and facebook page. We only had 1 resident pickup a trailer load. The sand is still available at the recycling center for pickup. Once the sand was removed we back filled the courts with dirt. We will put a final grade on and seed it in the spring once the ground has a chance to settle.

Bulky trash pick up was 18-19. Went smooth. 2 full containers on Friday which were changed out for 2 empties for Saturday. Saturday 4 full containers for a total of 6. The containers were hauled away starting at 6 am Monday morning.

Streets:

Sweeping of streets is being done on regular basis. This helps with the spread leaves, and clogging storm drains.

This is for both streets and public property. Hazardous Mitigation plan was submitted Green Lake County. This plan for natural disasters (ie tornado, winter storms, flooding.) that could affect the city.

Dear Resident(s)

The City was unable to dispose of your leaves due to the reason listed below:

Leaves cannot be raked into the streets

There is no curbside collection of grass clippings or mulched leaves.

When the mulched leaves get wet due to rain/snow our equipment does not have the capability of picking up the wet mulch.

Mulched leaves and other compostable items may be taken to the Recycling Center, located at N2298 Cty Rd A, east to the City. The Center is open every Saturday from 8 am to 2 pm.
